A Woman's Place (AWP) is an organization dedicated to ending domestic violence throughout Bucks County and has been operating for more than 45 years. In that time, AWP has leveraged Federal funding opportunities through our membership with the Pennsylvania Coalition Against Domestic Violence (Act 44, FVPSA, Title XX, Medical Advocacy, CLR), along with successful applications through the Pennsylvania Commission on Crime and Delinquency, which manages federal funding through VAWA. We are currently involved in one Victims of Crime (VOCA) grant for 2.1 million dollars through VAWA. In addition, AWP has successfully leveraged funds from the Department of Justice to combat human trafficking and, due to COVID, we have successfully extended this grant for one year to address the need for further human trafficking support in our community. Along with these funding sources, AWP has successfully worked with the CoC and Bucks County Department of Housing and Community Development to leverage ESG and ESG-CV funds to expand rapid rehousing. Current and past grants have allowed the organization to grow from one small shelter to a 24/7 helpline, a full housing program with a shelter and rapid component, legal services including legal council, victims response, trauma-informed therapy and counseling, education, human trafficking and advocacy at every level.

2. Describe your organization's (and subrecipient(s) if applicable) experience in leveraging Federal, State, local and private sector funds.

AWP has successfully leveraged funding to support its programs and services for more than 45 years. In the beginning, the organization relied almost totally on community support, but as it has grown and professionalized, AWP had become adept at leveraging sources of funds through Federal, State, regional and private sources. Our current VOCA grant through PCCD is a 3-year, 2.1 million effort that provides support for 20 of our 38 employees. In addition, we are a member of PCADV, which provides \$600K in funding each year. AWP also participates with the District Attorney and Network of Victims Assistance in funding through the Office of Victims and Witnesses as well as through the STOP Grant. AWP has a grant with DOJ for more than 700K to combat human trafficking in Bucks County as well. In working with our local CoC and Bucks County Office of Housing and Community Development, we have been awarded funding through CARES, ESG and ESG-CV. This funding has allowed us to launch and sustain our rapid rehousing program through the pandemic. Finally, individuals, our social enterprise and regional foundations provide at least 1/3 of our funding per year.

Currently the financial management of AWP is a two-tiered structure, where we are leveraging the services of a consulting accounting firm, Your Part-Time Controller, with expertise in grant management, audits, budgeting and other projects as needed. In addition, we have a contract CPA to manage our ongoing financial needs, monthly reporting and oversight of grant billing. We also employ a full-time bookkeeper to oversee daily financial functions. Finally, the Executive Director has more than 20 years of non-profit experience at every level to provide grants and financial oversight regularly. AWP has a comprehensive fiscal manual to assure all compliance with a multitude of funders. Finally, AWP holds regular finance committee meetings with board members to review financial functioning and the board of directors reviews financials at each meeting.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

AWP requests support for the rapid rehousing (RRH) program. Specifically, funding will be used for rental assistance and applied to current RRH case manager salary, add a RRH specialist & fund a part-time specialist to create coordinated service entry with other providers, creating a RRH team. For 45 years AWP has been Bucks County's only provider of comprehensive services to all domestic violence (DV) survivors. Services include a 24/7 hotline fielding 6000 calls in FY21, a safe house, rapid rehousing, adult & children's counseling, trauma-informed therapy, victims response, medical & legal advocacy, legal counsel & empowerment programming. In FY21, AWP provided 59 adults & 60 children with emergency housing through shelter & hotel. AWP operates a facility with 7 rooms & 13 beds but it does not adequately meet housing needs of those fleeing DV, especially with required social distancing. Hotels provide a short-term housing solution but are not sustainable due to availability & price. During COVID AWP expanded it's rapid rehousing program with ESG-CV funds addressing housing needs. Since January 2021 the full-time RRH case manager has permanently housed 15 survivors & their children. Also, 15-20 families are working with the case manager toward units becoming available. Housing units are difficult to find in Bucks County due to high prices and little development. The case manager creates relationships with landlords, provides safety planning, case management & referral. Providing 15 families with permanent housing has helped AWP shorten shelter time, providing space for other families in crisis. With the DV Bonus, AWP will increase the program's success & address barriers present within it. AWP will hire another full-time RRH specialist to maintain those housed and add another 10 per year. AWP will increase active caseload of those working towards permanent housing from 20 to 40. AWP will also work towards seamless entry by hiring a part-time coordinated entry specialist who will train other providers in DV client needs, work through coordinated entry barriers & act as a liaison between providers. AWP provides emergency shelter for those at "significant risk from DV, fleeing dangerous situations," meaning clients must be in active crisis. While shelter is essential to safety, there is limited capacity meaning no room for survivors not in immediate danger but at risk of homelessness. By expanding capacity, AWP can support those in imminent danger and those at risk for homelessness, filling a significant system gap. Additionally, DV survivors often have co-occurring issues - mental illness, drug, alcohol dependency & high levels of trauma. Providing additional support with added personnel & program consistency, the team can provide safety planning, AWP program connection & referrals to supports (workforce development, mental health, drug & alcohol counseling & childcare) so they can remain independently housed.

1. Describe how program participants will be assisted to obtain and remain in permanent housing.

Survivors work with AWP’s team specially trained in DV & RRH. Manager has established relationships with landlords overcoming objections in leasing to those with DV history. Team works with survivors determining need & safety planning. They create a relocation plan with legal DV protections available. When an acceptable unit is found, team facilitates rent, security deposit & reviews lease with survivor. Once signed, team & survivor identify furnishing needs & use matching funds for purchase. The team works with survivor for up to 12 months depending on need to pay rent, provide referrals, & identify issues. Survivors can remain in AWP programs as needed to address trauma, legal counsel, & build skills. AWP provides programming for workforce development, financial & computer literacy & legal navigation. RRH team coordinates with Bucks County Opportunity Council helping participants enroll in a self-sufficiency program, apply for food stamps, SSN, medical, childcare, disability, etc.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

Currently, all AWP advocates provide some level of case management and provide referrals to outside systems as needed. Referrals are based on the empowerment model, confidentiality provisions and the need of the client. Survivors who are not actively working within one of the programs (Safe House, Counseling, Victim Response, Legal Counsel) utilize the hotline for information and referrals. Often, survivors who are homeless due to domestic violence but not at imminent safety risk fall into this category. While survivors receive helpful information and support, it does not allow for warm handoffs, coordinated efforts and follow up contact unless initiated by the survivor. The addition of a coordinated entry specialist would allow for more comprehensive services of survivors who do not meet the threshold of needing emergency domestic violence support but would still benefit from working with a specialist who is trained as a domestic violence advocate and holds absolute privilege.

7D. Certification
