BCOC is a Community Action Agency that operates under the federal guidance of the Community Services Block Grant (CSBG). BCOC currently operates two federally funded Continuum of Care (CoC) programs for Rapid Rehousing and Coordinated Entry. The CoC Rapid Rehousing program assists homeless households in Bucks County to achieve permanent stable housing after experiencing episodic homelessness. BCOC works with partners in the Bucks County Housing Link, the central intake and coordinated assessment, to assess which households are the most vulnerable and prioritize those households for services.

BCOC maintains a lead role in the Housing Continuum of Care Bucks County (HCOC-BC) through participation in the Executive Committee, Co-Chair of the CoC at large and Chair of the Training Committee. As well, BCOC maintains leadership in the HCOC-BC service areas which include coordinated entry, street outreach, housing location, prevention and diversion, case management, rental assistance, rapid rehousing, and landlord risk mitigation. The Linkages to support these housing activities include United Way Bucks County, Bucks County Department of Housing and Community Development, Bucks County Department of Human Services, Pennsylvania Housing Affordability and Rehabilitation Enhancement Fund (PHARE), HUD ESG and CoC funding, and Pennsylvania Homeless Assistance Program (HAP).

BCOC is funded through Federal, State, and local funding to fulfill the agency's mission. BCOC leverages private resources to make the government funds stretch further, in turn assisting more people. BCOC matches current CoC projects with a mix of government and private resources.

BCOC is audited annually by a Certified Public Accounting Firm. Financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles. The Board of Director's Finance Committee oversees fiscal accountability, stability, and integrity in the support of programs and the mission of the agency. Our operating and financial computer systems maintain each contract's information in a separate section or fund with its own budget, year-end, and chart of accounts. The accounts receivable, accounts payable, and payroll expenses are allocated to each fund from the

agency-wide money market, checking, and payroll bank accounts. This system allows for an efficient accounting of all contractual expenses with no duplication of effort.
