The Bucks County Housing Link Centralized Intake and Coordinated Assessment (CI/CA) serves as the central point of intake for individuals & families seeking homeless services in Bucks County. The CoC & FSA worked together to create this CI/CA System, funded in part by this grant, and five Assessment Centers. The Housing Link serves all populations facing homelessness; Uses a standardized assessment/screening tool (VI-SPDAT) at three sites and through Street Outreach workers throughout the County to provide ease of access; Has protocols to insure that the needs of individuals and families who are fleeing, or attempting to flee domestic violence, dating violence, sexual assault, or stalking, but who are seeking shelter or services from non-victim service providers are met; Integrates prevention and shelter diversion activities into Housing Link operation; Has a referral process detailing responsibilities of the Housing Link and CoC member agencies; and has successfully applied for and received private grants to supplement available federal funds.

From 2/1/20-1/31/2021, 3,010 households accessed the Housing Link. Staff referred over 90%, 2,723, of callers to the CA sites to receive an assessment and referrals to homeless services. The remaining callers were provided with Information and Referrals (I&R) for other services including Food Pantries, Health Care, Fair Housing/Legal Aid, Education and Career Services, Mental Health and/or Drug & Alcohol, Utility Assistance, and other Community Services.

Housing Link will serve approximately 4,500 households in the next grant period. The Housing Link CI/CA program was able to hire new staff with the Expansion dollars awarded in FY 2018. The additional staff were able reduce the call-back time for those facing a housing crisis and answer more calls in real-time. A “no wrong door” approach has allowed a caller the ability to complete a screening and assessment in one step when the situation presents with urgent need.

Housing Link is advertised by the network of public and private agencies in Bucks County, by schools, health care providers, faith based organizations, and elected officials. Housing Link has a web page, [www.buckshousinglink.org](http://www.buckshousinglink.org) and major human service providers list the service on their websites and voicemail's. Business Cards with basic program information are distributed by street outreach providers and others. Many agencies help individuals and families contact Housing Link from their offices and they allow those callers to use their contact information to reach those who are transient or have limited access to cell phones.

Individuals and families facing a housing crisis call the Bucks County Housing Link Centralized Intake (CI) and are screened for services. Those who are within 30 days of losing their housing are referred onto the second step in the Coordinated Entry process which is a referral to the Coordinated Assessment (CA) site for an assessment using the VI\_SPDAT (Vulnerability Index- Service Prioritization Decision Assistance Tool). The tool is used to score the vulnerability and level of need for the individual(s) in need of housing services. The score then guides the staff to make referrals and place the individual(s) on the Community Waitlist for housing providers such as: emergency shelter or rapid re-housing, as appropriate.

The CI staff are also able to make a referral directly to the Street Outreach staff to verify homelessness and reduce the time it takes for an individual(s) to call for help to access emergency shelter and/or move into permanent housing.

The third resource the CI staff use is diversion. Working with the individual(s) to determine if there are any personal resources the caller has to resolve or delay homelessness.

The individuals and families who contact the Housing Link CI and do not meet the eligibility requirements for the housing providers are given other community resources in an attempt to resolve the issue they brought to the Housing Link staff.
