The Bucks County Continuum of Care (CoC) requests Planning Funds to support ongoing coordination and implementation of a high performing housing services system. Annually the CoC, through its Collaborative Applicant, the County of Bucks, assesses service delivery, outcomes and goals in an effort to refine and improve our system approach to prevent and end homelessness in our community. Ongoing evaluation considers success as well as constant need for improvement in order to meet community needs. The County's Housing Services Action Plan and policies and procedures address services and programs available to those facing a housing crisis and considers populations including veterans, victims of domestic violence, chronic homeless, youth and households with children. The strategic direction identified in the Housing Services Action Plan as well as a continuous review of performance outcomes within the CoC will be used by the County of Bucks in the development of the jurisdiction's annual Action Plans and in funding decisions for other housing/social service funding streams including the Emergency Solutions Grant.

Funding from the FY2021 CoC Planning Grant as well as from prior years will enable the CoC to continue to operate in full compliance with the provisions of 24 CFR 578.7 and will ensure the County's Governance Charter is current and inclusive of all operational requirements, including those for the HMIS system and Coordinated Entry. Bucks County's CoC will continue to establish performance targets appropriate for population and program type, monitor recipient and sub-recipient performance, evaluate outcomes of projects funded by the Emergency Solutions Grants program and the CoC program, address poor performance within the system and report to HUD as appropriate.

The CoC will continue to review measurable performance outcomes, effectively monitor and evaluate community-wide performance of housing and service programs for the homeless, including those funded through the CoC, ESG and other funding sources. The CoC has strategic priorities and outcome measurement tools in place, as exhibited in the CoC Consolidated application to assess our system to continually update goals, refine and outline our priorities and strategies based on current, identified community need and to correspond with Home, Together: The federal strategic plan to prevent and end homelessness.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Building on the Housing Services Action Plan and adopted CoC policies and procedures, the goals, objectives and benchmarks will be carefully monitored, reassessed regularly and progress will be measured to ensure the performance

of the system and client service programs are meeting the goals through measurable outcomes. The CoC Executive Committee, in partnership with its Collaborative Applicant, the County of Bucks, will oversee the activities of sub-committees at least quarterly to ensure progress toward the goals identified in the plan. The CoC, including various sub-committees, will continually monitor program performance and outcomes while working to implement best practices as identified by HUD.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The CoC's Outcomes/Data Management Committee is responsible for evaluating the performance of homeless housing and service provider programs throughout the jurisdiction. The plan is to continue to review and refine the Housing Services Action Plan which will better enable the CoC to monitor its performance for CoC funded and non-CoC funded programs. Specific outcome measures will be defined for each program type and for the Continuum as a whole that correspond with the plan goals. The CoC defines which measurements are needed, how to use the data to measure the outcomes and help implement a fair and transparent review process. Program outcomes will be reviewed on a consistent basis. During the monitoring process, it is expected that certain programs be identified as "high" or "low" performing programs. High performing programs may be replicated so that effective models for housing or services are used consistently across the CoC, and lower performing programs may receive assistance from the CoC to identify ways to improve outcomes. Consistently lower performing programs will be considered for reallocation in subsequent years as funding for these programs becomes more competitive. By identifying local and national informed benchmarks for each outcome measurement, the CoC will focus on improving both immediate and long term outcomes. We will monitor our progress using plan goals as well as standards set by Home Together: The federal strategic plan to prevent and end homelessness. Updated performance measures will be used by the Bucks County Housing Services Department in evaluating applications for federal and state Emergency Solutions Grant funds.
