1. Provide a description that addresses the entire scope of the proposed project.

The project serves a minimum of 18 youth, who, while of legal age, are ill-prepared for independence due to histories of trauma and abuse, and lack of family resources. Staff provide coaching, consistency, and model appropriate behavior while youth develop the skills and resources for independence. Using a Housing First approach, youth are selected based on vulnerability through the CoC’s coordinated entry process. In the event that there are no youth meeting the category 1 or 4 homeless definition, the project will enroll category 3 youth. Program development and quality assurance are informed by diverse leadership that is representative of the racial, ethnic and LGBT+ communities being served, through the incorporation of feedback from persons with lived experience (on the Board, the staff and through customer surveys and focus groups), through a Board-level DEI committee and staff participation in local community efforts to advance equity.

The program includes:

TRANSITIONAL HOUSING: A leased 3-bedroom unit houses 3 youth (for up to 90 days) at a point in time for those who are either unprepared to take on a lease in their own name or who are on a waitlist for housing. With the unit in the agency’s name, youth can immediately enter safe housing, become stabilized, and prepare for permanent housing (i.e. obtain ID’s, address mental health, prepare for work).

MEDIUM TERM RENTAL ASSISTANCE is provided to a minimum of 15 youth at a point in time. Scattered site apartments are located with easy access to community-based services. Rental assistance is reduced over time based on individual ability in order to prepare youth for full financial responsibility. During COVID that process has been slower with employment challenges.

CASE MANAGEMENT: Youth in both the TH and RRH components develop an individualized Housing Stability Plan (HSP) to outline the process and timing of reaching their goals in the areas of housing, education, employment, and permanency. The plan is updated minimally every 3 months. Case management includes regular face to face contact for a minimum of an hour a week, with up to 5 hours weekly for youth with more intensive needs. Case management centers on connecting youth with mainstream resources and developing and implementing plans identified in the HSP. Case management can continue up to 6 months after conclusion of rental assistance. Service methods include Positive Youth Development strategies, trauma-informed care and the use of risk and protective factors in assessing youth housing and service needs. Connecting youth to local resources allows them to get established with connections that will ground them after the conclusion of formal services. Linkages include: school liaisons and other educational support; employment programs; mental health services; family planning; food banks; and thrift shops.

75% of youth will achieve permanent housing at program exit and 60% will increase total income.

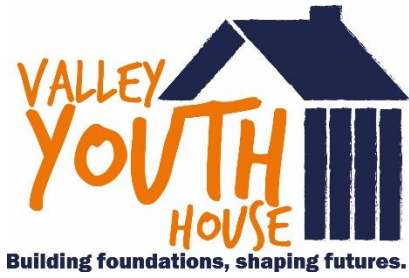
